

## Affiliate Membership Eligibility

The following organizations are eligible for affiliate membership in the American Association of Colleges for Teacher Education (AACTE):

- Not-for-profit, 2-year or 4-year, degree-granting foreign institutions of higher education
- Not-for-profit companies, organizations, state education associations, regional education laboratories, university-based research or policy centers, schools or other not-for-profit educational associations
- For-profit organizations, associations, agencies, centers, corporations or commercial companies
- Educator preparation programs operated by state agencies, regional/county education service agencies, or public school districts

## Affiliate Membership Categories

**NATIONAL OR INTERNATIONAL ASSOCIATION, AGENCY, NON-PROFIT, OR INSTITUTION** may appoint two individuals from their organization to serve as a chief representative and institutional representative.

**STATE OR REGIONAL ASSOCIATION, AGENCY, OR NON-PROFIT** may appoint two individuals from their organization to serve as a chief representative and institutional representative.

**CORPORATE AFFILIATES** may appoint 2-10 individuals from their organization to serve as a chief representative and institutional representative, based upon their employee size.

All representatives and contacts for the organization must be employed by the organization and have an email address that aligns with their domain name.
